Board Advisory Council recommendations for Action Items added to the upcoming April 23, 2024 Board Meeting agenda:

Action item #1 - Annexing into the City of Destin with the following items for negation:

- 1. Update the "Inter Local Agreement Modification" existing agreement.
- Exclusive and modified long term billing of city fields for our athletic programs (i.e. to host all of our programs at modified and reasonable rates or even agreements for maintenance only)
- **3.** Ask the city to consider recognizing DHS as the official City of Destin High School!
- **4.** Ask the city to provide any annual grant to the school to assist with educating the students in Destin? For example, maybe we ask for them to fund a fishing teacher position as that is vital to our economy.
- 5. Are there any infrastructure requirements we should ask for as guarantees? For instance, maintenance of our parking lot, areas in the front of the school, roadways, or right-of-way's?
- **6.** A seat at city council like an "Educational Czar" position so we always get to have representation.
- 7. Are there any city services we should ask for for instance, use of fields could possibly be at a cost or maintenance rate as mentioned above... use of city buildings for meetings could be free, etc...?
- **8.** Exemptions for any ordinance that doesn't apply logically to educational institutions.
- 9. We should ask to be invited to participate in city organized activities
- **10.** We should ask for a method of dispute resolution in the event we have a conflict or disagreement
- **11.** Should we ask for the city to invest in any infrastructure (such as installation of synthetic turf, drainage systems, tennis courts, etc...) or at least ask to be included in City Facility Planning Meetings as an official partner.
- **12.** The right to have priority in scheduling major events that require use of fields
- **13.** We should also ask if fields that we improve are used for events that generate revenue that we put a revenue sharing agreement in place with the city.

<u>Action item #2</u> – Look into what OCSD is offering staff for Cybersecurity Training and/or look into a Cybersecurity Training for all of the DHS staff. This is such an important training in today's world.
